The Arkansas Department of Health ("DOH") discussed in Volume 30 (No. 3) of the Fall 2017 edition of the publication *Arkansas Drinking Water Update* the redesign of its webpage.

An article authored by Jeff Stone noted that the redesign includes webpages dedicated to drinking water and the DOH Engineering Section

DOH has primacy under the federal Safe Drinking Water Act. Its duties include administration of the public water supervision program including protection of drinking water sources.
