- Served as lead appellate counsel for a state constitutional officer before the Arkansas Supreme Court in a lawsuit alleging violations of the Arkansas Whistle-Blower Act, obtaining a complete victory on appeal in a landmark decision interpreting Arkansas's sovereign-immunity doctrine.
- As lead trial counsel, obtained a directed verdict during the second week of trial on behalf of Arkansas's largest healthcare system and two affiliates in a wrongful death case involving misguided allegations of Medicare fraud and patient abuse.
- Defended a national life insurer as lead counsel against conspiracy allegations and claims under the Arkansas Trade Practices Act, securing the dismissal of the client on a preliminary motion to dismiss.
