On June 14, 2022, the Director of the Division of Environmental Quality (DEQ) signed Emergency Order (EO) LIS 22-068. The EO was issued to Mena Short Stop, LLC (MSS) pursuant to the Remedial Action Trust Fund Act, Ark. Code Ann. §\$ 8-7-501 et. seq.; the Hazardous Waste Management Act, Ark. Code Ann. §\$ 8-7-201 et. seq.; the Arkansas Water and Air Pollution Control Act, Ark. Code Ann. §\$ 8-4-101 et. seq.; the Arkansas Solid Waste Management Act, Ark. Code Ann. §\$ 8-6-201 et. seq.; and the Arkansas Pollution Control and Ecology Commission ("Commission") rules promulgated thereunder.

On June 23, 2022, MSS filed a Request for Hearing with the Commission. On June 24, 2022, the Commission's administrative law judge (ALJ) held a telephone conference with the parties.
