## AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Vicksburg Warren County Landfill LLC, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated August 21, 2015, Respondent was contacted by Complainant and notified of the following violations at the Warren County Landfill Class I rubbish site:

- A. Failure to provide earthen cover to the waste every two weeks as required by ACT 6, T-10 of Solid Waste Management General Permit No. SWGP R1 085 (Permit) and 11 Miss. Admin. Code Pt. 4, R. 1.6.E (7) of the Mississippi Nonhazardous Solid Waste Management Regulations (Regulations);
- B. Failure to immediately remove unauthorized waste from the disposal area in violation of ACT 6, T-7 of the Permit and 11 Miss. Admin. Code Pt. 4, R. 1.6.E(5) of the Regulations;
- C. Failure to inspect each incoming load for unauthorized waste in violation of ACT 6, T-7 of the Permit and 11 Miss. Admin. Code Pt. 4, R. 1.6.E(5) of the Regulations;

- D. Failure to prevent the disposal of unauthorized waste in violation of ACT 6, L-2 of the Permit and 11 Miss. Admin. Code Pt. 4, R. 1.6.D of the Regulations; and
- E. Active working face appeared to be of larger size than practical in violation of ACT 6, T-11 of the Permit and 11 Miss. Admin. Code Pt. 4, R. 1.6.E(14) of the Regulations.

2.

Based on multiple inspections conducted by MDEQ since the August 21, 2015 letter, Respondent has returned to compliance at the Warren County Landfill Class I rubbish site.

3.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$8,000. Respondent shall pay the first of two installments in the amount of \$4,000 to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director, or his designee (the "Effective Date"). Respondent shall pay the second installment in the amount of \$4,000 within ninety (90) days after the Effective Date. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. § 49-17-31, and that it has made an informed waiver of that right.
