AGREED ORDER

COME NOW the Mississippi Commission on Environmental Quality (Commission), acting through the staff and Executive Director of the Mississippi Department of Environmental Quality (MDEQ), Complainant, and Hunt Southland Refining Company, LLC, Respondent, in the above captioned cause and agree as follows:

1.

By letter dated October 27, 2020, Respondent was contacted by Complainant and notified of the following violations of Title V Operating Permit No. 2780-00059 at its facility in Warren County:

- A. Condition 5.B.3: The permittee failed to install a non-resettable hour meter on Emission Point AA-007.
- B. Condition 3.B.7: The permittee failed to comply with the maintenance requirements for Emission Point AA-007.
- C. Condition 5.B.5 (d) and (g): The permittee failed to keep records of all maintenance performed on the air pollution control and monitoring equipment and records of the hours of operation of the engine that is recorded through the non-resettable hour meter.

By letter dated November 4, 2020, Respondent asserted a non-resettable hour meter was installed on September 4, 2020 and the maintenance requirements are being met.

3.

In lieu of a formal enforcement hearing concerning the violations listed above, Complainant and Respondent agree to settle this matter as follows:

A. Respondent agrees to pay and Complainant agrees to accept a civil penalty in the amount of \$45,000.00. Respondent shall pay this penalty to MDEQ within forty-five (45) days after this Agreed Order has been executed by the MDEQ Executive Director or his designee. The settlement payment shall be submitted to:

Nothing in this Agreed Order shall limit the rights of MDEQ or the Commission in the event Respondent fails to comply with this Agreed Order. The Agreed Order shall be strictly construed to apply to those matters expressly resolved herein.

Nothing contained in this Agreed Order shall limit the rights of MDEQ or the Commission to take enforcement or other actions against Respondent for violations not addressed herein and for future violations of environmental laws, rules, and regulations.

6.

Respondent understands and acknowledges that it is entitled to an evidentiary hearing before the Commission pursuant to Miss. Code Ann. § 49-17-31, and that it has made an informed waiver of that right.
